## **1. Brief facts of the complaint**

The complainant has alleged that S/Shri Jaswant, Rakesh, Amit, Deepak, Akash, Arjun, Vikas, Ganeshi, Om prakash and others entered his house and attacked him with knife, lathis, iron rods etc. and injured him and his family members on 27.4.2013. They also tore the clothes of his wife and threatened to kill them. PCR was informed and their MLCs were prepared from GTB hospital. The doctors mentioned about inscise wounds and other blunt injuries. The complainant requested the police for registration of a case and also met DCP on 21.10.2013 but a regular FIR has not been registered by the police. The complainant has requested to direct the police to take necessary action in the matter.

## **2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing on 17.2.2014, the second hearing on 24.3.2014 and the third hearing on 21-04-2014.. At the latest hearing, the attendance was as follows :-

## **3. Relevant facts emerging during the hearing**

An ATR has been filed by Shri Jitendra Mani, Addl. Deputy Commissioner of Police-II, N/E District, stating that:-

"a case FIR No.327/14, under Sec. 354/324/506/34 IPC dated 26-03-2014, PS Nand Nagri has been registered on the statement of Smt. Anuradha Goyal (copy enclosed). And explanation has been called from SI Shashi Kant, D-4876 vide this office No. 3881-82/HAP/NE(P-I) dated 17-04-2014 (copy enclosed)". A copy of ATR has been given to the complainant.

The Commission enquired from the complainant about the receipt of the copy of FIR. The complainant stated that he had not yet received a copy of FIR. As such a copy of the FIR has been provided to the complainant for his information. The complainant also stated that proper section had not been applied in his case and the accused were yet to be arrested.

**4. Directions of PGC**

**SHO, Nand Nagri is advised to direct the I.O. to conduct proper investigation and take action regarding arrest of accused and finalise the investigation in a time bound manner.**

**Addl. Dy Commissioner of Police (N/E) is required to intimate the Commission about the final outcome of the explanation sought from SI Shashi Kant, by 30-06-2014 positively.**

Thus, with the intervention of the Commission, the grievance of the complainant regarding legal action on his complaint has since been resolved by way of registration of FIR under appropriate sections of law, and that was the only grievance of the complainant. The Commission has, therefore, decided to close the case with the above advice to the I.O. and Addl. Deputy Commissioner of Police (N/E).
