### 1. Brief facts of the complaint

The complainant has stated that she is living with her youngest son Shri Niranjan Singh Tokas and her eldest son Shri Jagdeep Singh Tokas is not allowing him to undertake construction at his portion of the land and is thus causing mental harassment to the complainant as well as her youngest son.

#### 2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 13-05-2014, when following were present:-

#### 3. Relevant facts emerging during the hearing

An ATR has been filed by SHO/Vasant Vihar stating that :-

"The son of the complainant Nyay Deep Singh was contacted and patient hearing was given, since the subject matter of complaint pertains to distribution and construction of ancestral property, the parties were advised to approach Civil Court as the matter pertains to purely Civil nature. No police action is required. In view of the above facts and circumstances, since the matter is civil in nature, no police action is required"

Complainant's son also stated that his brother was also extending threats to them and he apprehended some quarrel/physical assault by him.

#### 4 <u>Directions of PGC</u>

SHO/Vasant Vihar, may therefore, look into the matter and, if necessary, consider initiating preventive proceedings to maintain peace and law and order.

With the above advice, the Commission has decided to close the case.
