**1. Brief facts of the Complaint-**

The complainant has stated that on 08.10.13 while he had gone for morning walk from his house and reached Karkardooma Court Road, a cycle rickshaw along with a passenger hit him from behind and as a result he fell down. The rickshaw driver and his accomplice beat him up with dandas, fists and Kicks and the complainant received serious injuries. The complainant also alleged that the accomplice of rickshawala also took Rs 100 from he complainant. He was taken to Dr. Hedgewar Hospital for medical examination. The officials of Hedgewar Hospital referred the complainant to GTB Hospital. The complainant then went to RML Hospital and got IInd MLC prepared. As a result of the incident his hand was broken. The complainant has alleged that the police is not making sincere efforts in his case and the second accused in the case has not been arrested by the police. The complainant has requested to direct the police to investigate the matter in a proper manner and take necessary action against the alleged party.



## **2. Proceedings in the Public Grievances Commission-**

The PGC has convened its first hearing on 17.02.14, 2<sup>nd</sup> Hearing on 21.04.14 and the 3<sup>rd</sup> hearing on 21.04.14 and following were present on the said date of hearing-

## **3. Relevant facts emerging during the hearing-**

An ATR has been filed by Sh. Ajay Kumar, Dy. Commissioner of Police (East) stating that-

"2<sup>nd</sup> MLC result from Rml Hospital has been obtained in which Dr. Samar Rahman sr. SV. RML Hospital has opined that "as per record, nature of injury was simple" The investigation of the case has been completed and chargesheet will be filed in the Hon'ble Court for judicial verdict".

The I.O. also informed that the investigation of the case was almost ~~complete~~ <sup>complete</sup> complainant and the case file was being sent for scrutiny and charge sheet will be filed within 15 days times in the Court.

Thus, the police has already looked into the complaint of the complainant regarding second opinion in respect of injuries sustained by him, from RML Hospital, where the doctors have again opined the nature of injury as "simple".

## **4. Directions of PGC**

Since the police has already registered a case, the I.O. is advised to file charge sheet in the case within a period of 15 days. As no further action is required, the commission has decided to close the case.
