1. Brief facts of the complaint

The complainant Babu Lal has filed a complaint alleging that Smt. Laxmi Devi, wife of late Shri Rajinder (brother of the complainant) and police officials posted in PS Kalyanpuri had extended threat with dire consequences. They forcefully acquired ~~the~~ ^{his} tea shop which is situated at 16 Block Central Market Kalyanpuri. This shop was allotted to ~~their~~ ^{his} father. The complainant further alleged that Laxmi Devi sold the above said shop to Shri Braham Pal, r/o Dhallupura. The complainant has requested to take legal action against the erring police officials and Smt. Laxmi Devi, wife of late Shri Rajinder.

2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 12th February, 2018, when the following were present:-



shop to Braham Pal, r/o Dallupura. In this regard, a case FIR No. 596 u/s 448/380/34 IPC was registered in the PS Kalyanpuri on 29.11.2017. Six persons were arrested in this case. The allegation against police officer could not be substantiated. Hence, the complaint may be filed."

4. Directions of PGC

In view of the ATR filed by Delhi Police, the Commission has decided to close the case in PGC.
