1. Brief facts of the complaint

The complainant has filed a complaint stating that she had filed a complaint against her husband and mother-in-law regarding the offences of cruelty for dowry demand, mis-appropriation of her istridhan and cheating, committed by them with her. She further stated that an FIR No. 341/2015 , PS Begumpur, Delhi was registered u/s 498A/406/34 IPC and Section 4 Dowry Prohibition Act, and chargesheet was filed by the police before the Ld. Mahila court, Rohini Court, Delhi. However, despite of her specific allegation and documentary proof in support thereof regarding the offence of cheating, the police/IO did not file the chargesheet u/s 420 IPC or any other relevant provisions regarding the same. Resultantly, she filed an application u/s 156(3) Cr.P.C. for investigation and invocation of section 420 IPC in the abovesaid FIR. She further stated that the IO filed a status report before Ld. ACMM on 7.6.2017, wherein he has stated clearly false facts and has apparently created escape route for the accused Tarun goel. The IO seems to have connived with the accused while filing such false and misleading status report before the Honble Court. The complainant has requested for disciplinary action against ASI Ram Niwas, 318/OD, PS Begampur, who is IO in FIR NO. 341/2015.

2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 14th September, 2017, the second hearing held on 16th November, 2017, the third hearing held on 7th December, 2017 and the fourth hearing held on 4th January, 2018, when the following were present:-

3 Relevant facts emerging during the hearing

An ATR has been filed by SI Sumit Kuamr, PS Begumpur, stating that "the copy of supplementary chargesheet in the case FIR No. 341/15, u/s 420 IPC has been already supplied in last hearing of PGC. In regard to SCN vide NO. 10011-14/HAP-III/RD dated 20.7.2017 agaisnt ASI Ramniwas a reply of HAP/RD has been attached in which HAP/RD stated that the decision is still pending on the said SCN.

4. Directions of PGC

Shri Anil Goel, the father of the complainant is satisfied with the police action as far as the registration of the case and filing of chargesheet and supplementary chargesheet in the concerned court. However, he is yet to receive the information about the action taken against the police official who had misled the complainant.

DCP/Rohinist advised to conclude the final outcome on the show cause notice issued to the erring official ASI Ram Niwas. The final outcome shall be intimated to the complainant as well as the Commission, for its record, by 31st January, 2018.
