1. Brief facts of the complaint

Sh. Gulshan Kumar Ahuja filed a complaint in PGC on 20/11/2017 regarding non-payment of arrears by the Punjabi Academy in respect of Smt. Santosh Ahuja, Part-Time Punjabi Teacher expired on 20.4.2017.

2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 21.02.2018 wherein following were present :

3. Relevant facts emerging during the hearing

An ATR has been filed on behalf of Secretary, Punjabi Academy, Delhi, stating that *"Shri Gulshan Kumar Ahuja, husband of Late Smt. Santosh Ahuja has submitted documents for legal heirs after completing all the formalities in the month of September, 2017 in this office and after taking approval from the Competent Authority, the claim of*

Shri Gulshan Kumar Ahuja was passed in the month of October, 2017 and the same was informed to him. But due to non-availability of funds / grant-in-aid, the payment could not be made.

The Punjabi Academy is an autonomous body of Govt. of NCT of Delhi solely dependent on the grant received from the GNCT of Delhi and the request for grant of budget / grant-in-aid has already been sent to Govt. of NCT of Delhi for payment of arrears to the Part Time Punjabi Language Teachers as soon as we will receive the grant-in-aid from the Government, the arrears will be disbursed immediately to him."

As per the ATR, arrears to be paid to the complainant have already been worked out and the Department is waiting for the grant-in-aid from the State Government. As soon as the grant-in-aid is received from the Government, bills which have already been passed will be cleared.

4. Directions of the PGC

In view of the ATR filed by the Department, the case of the complainant is closed in PGC.
