**1. Brief facts of the complaint**

The complainant has filed a complaint in PGC stating that she is a teacher in Delhi Public School, Mathura Road, New Dehi and has been working there since 1983. She is a PGT-Biology. She further stated that she lodged a complaint with P.S. Nizamuddin regarding forgery of her signatures by a student whose parents are well known to the Principal of the School. The student whose details appear in the complaint to the PS Nizamuddin forged her signatures on school prep copy to obtain marks although she had gotten a zero for non-submission of copy for the entire year. She alleged that the SHO has not taken any action on her complaint ever since the complaint was lodged on 23.2.2017. This shows collusion between the Principal and the SHO, as the SHO could have easily sent the matter to Juvenile Justice Board for appropriate action. The complainant has requested to kindly summon the SHO and direct him to take appropriate action in the matter.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 29<sup>th</sup> August, 2017, the second hearing held on 31<sup>st</sup> October, 2017, the third hearing held on 6<sup>th</sup> February, 2018 and the fourth hearing held on 13<sup>th</sup> February, 2018, when the following were present:-

SI Chander Shekhar from PS H.N.Din is present and stated that DPS school is not in possession of any assignments/registers in respect of the student Ms. Sanjana Arora of class-IX-E (Academic Year 2016-17) bearing admission no. 06020. He further stated that the father of the student has conveyed in writing that he has disposed all the assignments of Class-IX-E (Academic Year 2016-17) in respect of her daughter Ms. Sanjana Arora as these documents are of no use to her in the current academic session, 2017-18 and also the school authorities had not informed them to keep the registers/assignments for future record.

## 4. Directions of PGC

In view of the above, the Commission has decided to close the case in PGC.
