## **1. Brief facts of the complaint**

The complainant has alleged that both the accused Shri Jagjit Singh @ Jaggu & Deepa Arya in FIR No. 463/15 P.S. Subzi Mandi, are still threatening her (the complainant), witnesses and also tampering with evidence. She has also requested to arrest both the accused for detailed interrogation to unearth the criminal conspiracy. She has further requested for adding section 120 B, 387 and 34 in the case to get justice.

## **2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 15<sup>th</sup> March, 2016, the second hearing on 7<sup>th</sup> April, 2016, the third hearing on 2.6.2016, the fourth hearing on 21<sup>st</sup> July, 2016 and the fifth hearing on 8.9.2016. The instant case was closed on 8.9.2016. The case has been re-opened and first hearing after re-opening the case has been held on 2.3.2017, the second hearing held on 1<sup>st</sup> June, 2017, the third hearing held on 17<sup>th</sup> August, 2017, the fourth hearing held on 14<sup>th</sup> September, 2017, the fifth hearing held on 23<sup>rd</sup> November, 2017 and the sixth hearing held on 8<sup>th</sup> February, 2018, when the following were present:

## **3. Relevant facts emerging during the hearing**

An ATR has been filed by SI Mukesh Kumar, Vigilance Branch/SD stating that "in continuation of previous report dated 23.11.2017, it is further submitted that an explanation was issued to Inspector Suresh Chand Verma on 21.7.2017 regarding the matter in question, who filed his reply dated 17.8.2017 mentioning therein that he was not responsible for the said matter/lapse. Comments regarding the reply of Inspector Suresh Chand Verma were sought from ACP/SJE by the then DCP/SD. ACP/SJE submitted his report dated 18.9.2017 mentioning therein that reply to the explanation

filed by the Inspector was found factually incorrect. (Copies of ECN dated 21.7.2017, reply dated 17.8.2017 and comments of ACP/SJE dated 18.9.2017 are enclosed for kind perusal.).

Another ATR has been filed by Inspector Brijpal Singh, Narcotic Cell/Crime Branch, stating that " the investigation of present case has recently been entrusted to undersigned Inspector. During course of investigation previous IO/Inspector Manoj Kumar had visited the spot alongwith Shri Gaurav Goyal, the complainant. CCTV footages were seen alongwith complainant. From the examination of CCTV footage in question, it is not clear as to whether the chain was snatched or not. There is not any evidence on record till date to corroborate the allegation of chain snatching. Medical opinion regarding injuries has also been obtained. As per MLC and Medical opinion, no any fresh external injury was seen on the body of the complainant. However, both the alleged advocates namely Jagjit Singh and his brother have been interrogated in the case. After discussion with senior officers & Prosecution, Invesigation will be finalized soon."

The Third ATR has been filed by Inspector Brijpal Singh, Narcotic Cell/Crime Branch, stating that " in continuation of previous status report, it is further submitted that investigation of present case has recently been entrusted to undersigned Inspector. In this case main chargesheet against accused (1) Jagat Singh @ Jaggu s/o late Shri Ram Singh r/o H.No. 635, Gulmohar Park, Shalimar Garden Extension, Shahibabad, Ghaziabad, UP and (2) Deepa Arya d/o late Shri V.P. Arya r/o 3/5 Rani Jhansi Road, Paharganj, Delhi has already been filed in the court. Supplmenetary investigation pertaining to t he aspect of mobile phones used for making call/SMS was to be carrued out. During further course of investigation, one mobile phone of Shri Gaurav Goyal and two mobile phones produced by accused Deepa Arya had been seized and sent to FSL for analysis and reort thereof has been received. The CDRs of mobile phone numbers 9810390971 (Gaurav Goyal) 9313351692 (Deepa Arya) & 9810370843 (Jagjit Singh) for the relevant period 15.3.2014 to 30.7.2014 were sought but the same could not be available because of the period of beyond one year. The bail cancellation order dated 18.9.2017 pertaining to Ms. Deepa Arya, was stayed by Hon'ble High Court vide order dated 19.9.2017 and next date in the matter is now fixed for 3.4.2018. N.B.W. issued against accused Jagjit Singh is still stayed till next date of

hearing i.e. 4.5.2018. Draft chargesheet has already been got scrutinized by Prosecution Branch and the same will be filed in court soon."

The fourth ATR has been filed by SI Ajay Kumar, PS/SJ Enclave, stating that "case FIR No. 400/2016 u/s 354/354-D/506/120-B IPC was registered on dated 20.5.2016 and after completion of investigation, chargesheet has been put -in-court on dated 3.1.2017 and next date of hearing is fixed for 12.3.2018 in the Hon'ble Court. However, one another case vide FIR No. 383/2017 u/s 387/509 IPC PS S.J. Enclave was registered on 15.9.2017 and after completion of investigation, chargesheet has also been put-in-court on dated 6.2.2018 and the next date of hearing is fixed for 4.7.2018 in the Hon'ble Court. Hence, it is further submitted that no case is pending trial in police station Safdarjung Enclave."

## 4.. Directions by PGC

In view of the ATRs filed by Delhi Police, the Commission has decided to close the case in PGC.
