#### 2. Proceedings in the Public Grievances Commission

The PGC has convened five hearings viz. four in the Board of Chairman, PGC on 30<sup>th</sup> May, 2017, 25<sup>th</sup> July, 2017,19<sup>th</sup> September, 2017, 21<sup>st</sup> Nov., 2017 and one in the Board of Member, PGC on 13<sup>th</sup> February, 2018. # Relevant facts emerging during the hearing

3.1 At the last hearing held on 21st Nov. 2017, the directions of PGC were as follows:

Shri Jitender Kumar, AE (Building), Karol Bagh Zone, North DMC shall take note of the Commission's advice in para 3.4 (viz. Sh. Jitender Kumar, AE (B), Karol Bagh Zone, North

Appellate Tribunal, MCD has filed the requisite documents with them or not. If yes, date of application and proof of receipt shall be given to the Commission for its perusal, within a week. If they have not received the requisite papers from the Appellant within 5 days, as ordered by the Appellate Tribunal, MCD, the department is advised to initiate further necessary action as per DMC Act, 1957) of this hearing order for compliance and ensure submission of an action taken report in this regard, before the Commission in the next hearing, through a senior representative.

- 3.2 During the hearing on 13.02.2018 a status report was filed by Asstt. Engineer (B), Karol Bagh Zone stating that the stay order granted by ATMCD in Appeal No. 879/2017, the ATMCD has extended the interim stay till the next date of hearing and adjourned the matter to 20.04.2018.
- 3.3 During the discussion it emerged that the Appellate has filed the requisite papers at ATMCD within the defined time.
- 3.4 It was further informed by the Asstt. Engineer (B) during the hearing that as the matter is pending at ATMCD no action can be taken by the officials of Building Department, North DMC.

#### 4. Directions of the PGC

- 4.1 AE (B), Karol Bagh Zone is advised to plead the case in the ATMCD on the next date of hearing to vacate the stay and then take action as per the DMC Act and submit an Action Taken Report on the next date of hearing.
- 4.2 The complainant is also advised to make himself a party in the Appeal case at ATMCD, if possible, to plead his case.
