1. Brief facts of the complaint

The complainant has filed a complaint alleging that he made complaints to various authorities regarding unauthorized parking near the wall of Moni Baba Mandir, situated in gali No. 10, Bharam Puri, Delhi which is creating obstruction for traffic, but no action has been taken by any authority. The complainant has requested for necessary legal action for removing this unauthorized parking.

2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 19th September, 2016, the second hearing on 20th Feb., 2017, the third hearing on 1st May, 2017, the fourth hearing held on 10th July, 2017, the fifth hearing held on 11th September, 2017 and the sixth hearing held on 12th February, 2018, when the following were present:-

3.. Relevant facts emerging during the hearing

An ATR has been filed by TI/SHD stating the following :-

i. In continuation of this office ATR report, dated 23.1.2018, it is further

submitted that there are total 24693 challans were issued for the period 16.11.2017 to 31.1.2018 by the Traffic Police of Shahdara circle against violators, out of which, vehicles towed away by Crane -152 and 3805 challan of improper parking. However, 07 notices & 20 cash challans were issued at the specific place mentioned in the complaint by the complainant i.e. in the surrounding area of Moni Baba Mandir.

- ii. It is further submitted that no such type of illegal parking is running at the above said area. However, it is noticed that some of the vehicles are parked at above said place related to local residents of the area and relatilves of the local residents, who comes to meet them.
- iii. A regular drive is being conducted time and again to remove unauthorized parking with the help of local police in different areas including the area under reference. Notices /challans are also issued against unauthorizedly parked vehicles and violators under applicable provisions of law. The surrounding area of the Moni Baba Mandir lane or bye lane are so narrow, where the movement of crane is difficult and to tow away the vehicle by crane is difficult.
- iv. Furthermore, the circle/crane staff has also been briefed and instructed to carry out frequent surprise inspections/checks/rounds of the area under question and if any vehicle is found improperly parked at this particular place, immediate appropriate action be taken against such vehicles/violators.

Another ATR has been filed by SHO/New Usmanpur stating that "in pursuance of the directions of Hon'ble PGC, total 01 challans & 05 notices have been issued against unauthorized parked vehicles and violators under applicable section of law and encroachment have been removed. The copy of challans/notices and photographs of the gali are encroached."

4.. Directions of PGC

The ACP/Traffic, District North/East is advised to brief Circle/Crane staff to carry out frequent surprise inspections of the area under in question and if any vehicle is found improperly parked, appropriate action shall be initiated against such
