## Brief facts of the complaint

The complainant has filed a complaint alleging that 02 police personnel, namely, Surender Kumar & Pritam Chand with collusion of other residents are facilitating a Bangladeshi Garbage picker boy in the colony despite of his objection. He also stated that the garbage boy does not have proper identity. The complainant has requested for necessary action in the matter.

#### 2. <u>Proceedings in the Public Grievances Commission</u>

The PGC convened its first hearing in the complaint on 8<sup>th</sup> February, 2018, when the following were present:-

### 3 Relevant facts emerging during the hearing

An ATR has been filed by SI Sandeep, Rohini District, stating the following:-

i. Enquiry in the matter has been conducted and both alleged police personnel furnished their replies in writing which reveals that there are 02 groups in Pkt-2, Sector-A/10, Narela. One group is of complainant Raman Sharma & the other one is of Mr. Anirudh Tyagi, President RWA. On 26.2.2017, group of complainant Raman Sharma was defeated from all sides in RWA Elections. Due to which he started enmity from the alleged persons and created an

another group with name of 'Bharat Apartments Narela Niwasi Kalyan Sangathan'. He also tried to remove all the workers hired by existing RWA. Alleged garbage picker boy was earlier hired by the complainant & he filed a complaint against him on the issue of non payment of his dues.

- On 20.8.2017, preventive action u/s 107/150 Cr.P.C. was initiated against both parties vide DD No. 13A by ASI Devender Kumar.
- iii. On 28.9.2017 complainant Raman Sharma misbehaved with Ms. Suchi Srivastava (Vice President RWA) and a case FIR No. 750/17, dated 29.9.2017, u/s 354/354A/509 IPC, PS Narela was registered against him (copy enclosed). Case is still pending investigation. Whether the boy Vishal (garbage picker) is Bangladeshi or not is not verified yet. The facts regarding this will be verified and suitable action will be taken.
- iv. The present complaint is outcome of old dispute between RWAs. Complainant Raman Sharma has filed present complaint in his defence with respect to FIR registered against him which is pending investigation. Nothing more is found required to be done in this matter. Hence, complaint may be filed please."

#### 4. Directions of PGC

The matter relates to dispute between two factions of RWAs. The complaint filed by the complainant has nothing against the police personnel.

In view of the above, no further action is required. The Commission has, therefore, decided to close the case in PGC.
