**1. Brief facts of the complaint**

Sh. Anil Dutt Sharma filed a grievance in PGC on 08.03.2017 against unauthorized construction carried out at C-5/16, Krishna Nagar and 308, Shri Ram Nagar, Delhi.

**2. Proceedings in the Public Grievances Commission**

The PGC convened five hearings since 1<sup>st</sup> May, 2017 and during the last hearing held on 26<sup>th</sup> February, 2018, the following were present:

**3. Relevant facts emerging during the hearing**

3.1 At the last hearing held on 18.12.2017 the directions of the PGC were as under :

*The Complainant is advised to file a written submission with regard to the Action Taken Report filed by the department at today's hearing, in the next hearing.*

3.2 *During the hearing on 26.02.2018 Sh. P.V.Singh, Ex. Engineer (B)-I, Shahadara South, EDMC was present who informed that the matter regarding property No. C-5/16, Krishna Nagar is being dealt with in a separate file and a report regarding action taken on the said property*

has already been submitted and further proposed action will be initiated in due course of time and report to this effect will be submitted simultaneously.

4. **Directions of the PGC**

The action against property No. C-5/16, Krishna Nagar is being dealt separately in another file. The other property listed in the matter is 308 Shri Ram Nagar. It has been informed by the complainant that the matter regarding property No. 308 Shri Ram Nagar is pending in the ATMCD and against that, the complainant has moved to High Court of Delhi. No further action is warranted for the time being in the matter at the level of PGC. Hence the file is closed.
