**1. Brief facts of the complaint**

Sh. Anil Dutt Sharma filed a grievance in PGC on 13.06.2017 regarding unauthorized construction carried out at A-26, Jagat Puri, Delhi.

**3. Relevant facts emerging during the hearing**

3.1 At the last hearing held on 18.12.2017 the directions of the PGC were as under :

*Shri P.V.Singh, Executive Engineer (Building)-I, Shahadara South Zone, East DMC is advised to ensure that a factual Action Taken Report is submitted to the Commission, which should be specific to the allegations made by the complainant, after taking action against the properties under reference, as per DMC Act, 1957.*

4. Directions of the PGC

**Executive Engineer (B)-I, Shahadara North, EDMC** is directed to submit a list of properties against which action like sealing / demolition etc. has been initiated on the directions of the Hon'ble High Court of Delhi or any other Court during the last three years, to this Commission.

**CVO, EDMC** is requested to fix the responsibility of the officers during the tenure of whom unauthorized construction has been carried out in property No. A-26, Jagat Puri, Delhi.
