**1. Brief facts of the complaint**

Sh. Kamal Singh filed a grievance in PGC on 01.08.2017 against unauthorized constructions carried out in the area of School Block, Shakarpur, Delhi – 110092 in various properties in connivance with the engineers of Building Department, Shahadara South Zone, East DMC.

**2. Proceedings in the Public Grievances Commission**

The PGC has convened four hearings since 25.09.2017 and in the last hearing held on 5<sup>th</sup> March, 2018 the following were present:

**3. Relevant facts emerging during the hearing**

3.1 At the last hearing held on 29<sup>th</sup> Jan. 2018, the directions of PGC were as follows :

*The matter was placed before the Commission but no officer from MCD attended the hearing in the case. Executive Engineer concerned is directed to be present personally on the*

next date. Commissioner to ensure that the senior officer well conversant with the case is present during the hearing in PGC.

3.2 During the hearing held on 05.03.2018 neither any officer is present nor any status report has been filed.

#### 4. Directions of the PGC

4.1 It was reported to the Commission that the buildings are unauthorizedly built and the matter has been brought to the notice of the Commission in the month of July, 17 when the construction was in progress. Now after 6 months it is learnt that the building has been completed and has been sold out thereby making the proceedings in the Commission in fruituous. At no point of time the officials of MCD attended the hearing which shows their disregards to the Commission and confirms presence of a nexus between the MCD officials and builders who have carried out illegal construction with impunity.

4.2 **Chief Vigilance Officer, EDMC** is requested to personally look into the matter and get it enquired, investigated to fix the responsibility of the MCD officials for initiating disciplinary proceedings against each of them for dereliction of discharge of duties and misuse of their official position and submit a report to this Commission.

4.3 With the above directions the case is closed at the level of PGC.
