### 1. **Brief facts of the complaint**

The complainant has filed a complaint of inaction against police authorities. He has stated that he had lodged several complaints with Delhi Police and civic agencies against his neighbour and his wife for their rigid and ill behavior against the complainant. He has further stated that the alleged neighbour was parking his vehicles in front of his house for loading and unloading, thus, affecting his access to in his own house. He has requested for legal action in the matter.

# 2. <u>Proceedings in the Public Grievances Commission</u>

The PGC convened its first hearing in the complaint on 14<sup>th</sup> March, 2018, when the following were present:-

## **Relevant facts emerging during the hearing**

An ATR has been filed by Inspr./ATO/Prasad Nagar, stating the following

i. Local enquiry was conducted by visiting the spot. It is found that the complainant Shri Kishan Singh resides in H.NO. 6634, Block No. 9, Gali No. 6, Dev Nagar, Karol Bagh, Dehi and the alleged Dinesh Kumar resides in adjoining house No. 6633. All the houses in gali No. 6, block No. 9, Dev Nagar are built beside the street leaving no parking space. The inhabitants park their vehicles in front of their houses in the street. The complainant Kishan Singh has one two-wheeler to park in the street in front of his house whereas the alleged Dinesh Kumar has one four wheeler to park in

the street in front of his house. The front sides of each house is not sufficient enough to accommodate a large vehicle/four wheeler. The insufficient parking space in front of houses of the complainant and the alleged is bone of contention between both of them. During enquiry, I had asked the complainant to give his statement in respect of harassment being mated out to him by the alleged but he refused to give his statement and verbally told that he has de-marketed his parking space in front of his house by pegging small iron pipes in the street. He further told that the said iron pipes may not be removed, as this is the only inconvenience he is anticipating from the civic agency as well as from his neighbour. It is also learnt that Shri Kishan Singh had made similar complaints to the Traffic Unit also and he has requested not to remove the said pegged iron pipes in front of his house in the street.

ii. The contents of the complaint are vague in nature and does not disclose commission of any cognizable offence by t he alleged person. The complainant is now relieved from the problem of parking his vehicle in front of his house. Hence, the complaint may be filed please."

### 4. Directions of PGC

In view of the above, the Commission has decided to close the case in PGC.
