**1. Brief facts of the complaint**

The complainant has filed a complaint of non-registration of FIR against SHO/PS Dabri . He has alleged that his five year old son while going for tuition went near the transformer to take a ball lying there. There was a gap between the ground and the fencing of the transformer due to which he could enter the area of the transformer. He has further stated that his son was injured due to a sudden blast in the transformer which has made him disabled for the whole life. They have been visiting the police station for the last six months to lodge FIR against the power company but all in vain. He has requested for legal action in the matter.
