**1. Brief facts of the complaint**

The complainant has filed a complaint against Shri Amar Singh, Smt. Kamlesh w/o Shri Amar Singh, Manish Kumar, Shiv Kumar, Satish Kumar, Deepak Kumar and others for beating and threatening her. She stated that on 3.8.2017 when she was washing her clothes in her house, Satish Umar and Deepak Kumar (Delhi Police employees) came and parked their bike in front of her house and when she objected for parking the bike, the parents of alleged used abusive language. All accused persons came out from their house and abused in filthy language and gave threats that “ hum police wale hain ilaka police main humari setting hai isliye wo hamara kuch nahi kar sake hai, tu widhwa aurat humara kiya kar legi there ghar main jawan ladkiya hai is baat ka dhyan rakh, kabhi bhi inhe uthwa sakat hai aur tere ladke ko kisi bhi jhothe case main faswa sakat hai.” She further stated that she called at No. 100. The PCR came. ASI Shiv Kumar, Incharge of PCR told the complainant that she (the complainant) was on fault and police will not take any action against the alleged persons as they are police man. He advised her to approach to DCP. She went to PS Mahindra Park and when she asked about the SHO, the duty officer told her that he do not know where was SHO and told her to go to her home. She further alleged that the alleged persons threatened the complainant for dire consequences for her and her children’ life. The complainant has requested for lodgeing an FIR agiasnt the alleged persons.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 7<sup>th</sup> December, 2017, the second hearing held on 8<sup>th</sup> February, 2018 and the third hearing held on 15<sup>th</sup> March, 2018, when the following were present:-
