### 1. Brief facts of the complaint

The complainant Smt. Laxmi Devi alleged that on 14.9.2017, ASI Ombir Singh Tyagi and three other police officials came to her husband's shop and picked him up for interrogaton purpose and detained him till midnight in Police Station of INA Metro Station, Delhi. The said ASI also threatened her that he would implicate her husband in 25 cases and extorted Rs. 50,000/- from her. The complainant further alleged that these police officers had beaten her husband badly and also snatched Rs. 23,700/- from him. She also alleged that police officer Om Vir Singh Tyagi and other police officials misbehaved with her by touching her chest and also abused her. The complainant has requested for legal action in the matter.

## 2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 21<sup>st</sup> November, 2017, the second hearing held on 6<sup>th</sup> February, 2018 and the third hearing held on 13<sup>th</sup> March, 2018, when the following were present:-

## 3 Relevant facts emerging during the hearing

The complainant is not present. During the hearing held on 21<sup>st</sup> November, 2017, the complainant was not present and,therefore, a copy of the ATR filed by Delhi Police was sent to her information and furnishing her comments, if any, on the next date of hearing, i.e. fixed for 6.2.2018. But she was neither present on 6.2.2018 nor furnished/sent her comments .She was again directed to be

personally present in today's hearing held on 13.3.2018, failing which her case will be closed in PGC, but again she is neither present nor sent/furnished her comments. The complainant has not attended any of the three hearings held in the Commission so far. Even after specific advise of the commission vide the previous two orders. It seems that she is not interested in pursuing her case in the PGC.

### 4. Directions of PGC

SHO/INA Metro is directed to call the complainant and give her a personal hearing. He shall take legal action in the matter as made out and a detailed report be sent to the Commission within a week of receipt of this order.

With the above advice, the Commission has decided to close the case in PGC.
