1. Brief facts of the complaint

The complainant has filed a complaint stating that the medical check up (MLC) of his 70 year old father was done by 15:30 hours on 18th June, 2017, but they were forced to sit inside the PS until 21.30 hrs without any reason. He also stated that at 18.30 hours he was stopped from going out of PS and HC Dheeraj hit on his left side of his face. HC Dheeraj not only hit him but also tried to justify his action by yelling that he will arrest him (the complainant) on spurious charges. The CCTV recording/footage of the camera which is directly over the reception and the entry/exit area of the PS Anand Vihar may also be checked to ascertain the truth. He also alleged that the HC asked some unknown person to take their mobile phones and they snatched mobile phone of his brother at that time while he was talking. He requested the Commission that the said incident can be verified from the recordings of the CCTV cameras installed in the PS. The complainant has requested to take suitable action against the officers who misused their authority.

2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 25th September, 2017, the second hearing held on 5th February, 2018 and the third hearing held on 12th March, 2018, when the following were present:-

3 Relevant facts emerging during the hearing

Three cases were registered for hearing on similar complaints filed by father son duo. Out of them, one has already been heard and closed in the Commission.

4. Directions of PGC

IO is directed to guide the complainant about the concerned Illaka Magistrate for taking cognizance in the NCR/ FIR registered by the police. Further, the complainant is advised to approach the court in the matter of NCR/ FIR. Police is advised to make a detailed report on the incident including the action taken in the matter/complaints for perusal of the Hon'ble Court/Magistrate as required.

With the above advise to the IO, the Commission has decided to close the case in PGC.
