1. Brief facts of the complaint

The complainant has filed a complaint in PGC alleging that her husband has married another woman without giving her divorce. She also alleged that her brother-in-law Mukesh and Jaiprakash misbehaved with her and pressurized her that if she does not give divorce to her husband Raj Kumar, they will get the acid thrown on her face and also get her son killed. She further alleged that on 21.6.2017, her husband and his goons were demolishing her house A-5/154 and run away with her household articles. Her husband is trying to sale this house. She also made a call at No. 100 regarding this incident but police is not taking any action on her complaint. The complainant has requested for necessary action in the matter.

2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 7th September, 2017, the second hearing held on 11.10.2017, the third hearing held on 22nd February, 2018, the fourth hearing held on 22nd March, 2018 and the fifth hearing held on 28th March, 2018, when the following were present:-
