## 1. **Brief facts of the complaint**

The complainant has filed a complaint against police officials of PS Uttam Nagar for inaction, misbehaving and calling her call girl etc. She has stated that a person Mohd. Bahar had live-in relations with the complainant and he used her for the flash trade due to which she got infected with HIV. She has also alleged that the alleged person persuaded the IO Sukhanda for not making any case against him in lieu of a bribe of Rs. 1 lakh. She has further alleged that while she made a complaint in this regard to the police, neither the SHO nor the IO heard her. IO Sukhanda rebuked her badly and called her by bad names like "gasti" call girl etc. She has requested for legal action in the matter.

## 2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on  $17^{th}$  January, 2018, the second hearing held on  $7^{th}$  March, 2018 and the third hearing held on  $6^{th}$  April, 2018, when the following were present:-

# 3 Relevant facts emerging during the hearing

### 4. Directions of PGC

The complainant is present and requested the Commission for closure of the matter stating personal reasons. As regards the allegations against police officials, she stated that the same has been done to pressurize the police as she was running in poor state of mind and mental stress.

Considering the police report and the submissions of the complainant, the matter stands closed in the PGC.
