1. Brief facts of the complaint

The complainant has filed a complaint against police officials of chowki, Okhla Industrial Area for destroying evidence of the case and not investigating it in a proper manner. She has stated that the police is not taking any legal action on her complaint of trespass and evicting her from her house. The complainant has requested for legal action in the matter.

The PGC convened its first hearing in the complaint on 27th February, 2018, the second hearing held on 6th March, 2018 and the third hearing held on 10th April, 2018, when the following were present:-

4. Directions of PGC

SI Anuj Kumar is present and informed that the instant case has been transferred to DIU/South East District vide R/C No. 138/21/18 PS-OIA for further investigation.

DCP/SED is advised to direct the concerned IO to contact the complainant and take forward the further investigation in the case.

Smt. Reenu Panchal stated that the facts placed by the police before the Commission are misleading and she submitted her comments/reply with regard to the same. A copy of the same is being forwarded to ACP/DIU, SED to take into account the submissions/comments submitted by the complainant and take action as per law.

With the above advice, the Commission has decided to close the case in PGC.
