1. Brief facts of the complaint

The complainant has filed a complaint against police officials of non-registration of FIR on her complaint against her in-laws for breaking her father's hip bone. She has stated that on 29.12.2017 when she returned to her marital home she found that her house was unlocked and was occupied by her sister-in-law, Rani. Her belongings were also not there. On enquiring in this regard, all the members of her in-laws assembled there and started beating her, her daughter and her parents. She made a call in this regard at No. 100 but the assailants did not desist even after the arrival of the police and broken the hip bone of her father. The police has not registered FIR in the matter even after a medical report in this regard. She has alleged that a police was not acting on her complaints as her jeth/brother-in-law Bharat Singh was in Delhi Police. She has requested for legal action in the matter.

2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 21st March, 2018 and the second hearing held on 11th April, 2018, when the following were present:-

3 Relevant facts emerging during the hearing

An ATR has been filed by SI Vijay Pal, PS Sector-23, Dwarka, stating the following :-

- i. In continuation of the previously filed ATR, it is further submitted that during course of investigation of FIR No. 375/17, interrogation from local residents have been made and the

old house where the household articles of complainant Smt. Bhawana is lying was visited.

After the same section 448 IPC has been added in the present case.

- ii. It is further submitted that alleged Bhai Ram and alleged Prem Chand has also joined the investigation of above mentioned case as per the Notice u/s 41A Cr.P.C. The investigation of the above case is being finalized and after that the same will be sent to Court for judicial verdict. Moreover, the complainant Smt. Bhawana has filed a case of D.V. Act against the alleged person and the same is pending before Hon'ble MM Court, Dwarka, in which NDOH-24/4/2018.
- iii. It is further submitted that all the necessary legal action in the above matter has been taken. Moreover, all the facts of the case has also been conveyed to the complainant."

4. Directions of PGC

The complainant is present and expressed apprehension to her life from the alleged party.

The complainant is advised if any threat is extended to her or her family members, she should immediately inform Police Control Room on 100 and local police station.

On receipt of complaint,SHO/Dwarka shall take immediate action as per law.

With the above advice, the Commission has decided to close the case in PGC.
