1. <u>Brief facts of the complaint</u>

The complainant has made a complaint against SI Kulbir Rana , PS Vivek Vihar for beating, abusing and threatening him. He has alleged that on 10.10.2017, at 8.30 p.m. he visited the friend at Indira Park, Kasturba Nagar. While he was waiting for his friend, the alleged SI alongwith three other policemen came at the spot and started abusing and beating him and he took out his service revolver at put it in his mouth and threatened to kill him. He also threatened him to implicate him in false cases. He made a complaint at No. 100 but no one turned up. He has requested for legal action in the matter.

2. <u>Proceedings in the Public Grievances Commission</u>

The PGC convened its first hearing in the complaint on 15th January, 2018, the second hearing held on 5th March, 2018, the third hearing held on 19th March, 2018 and the fourth hearing held on 23rd April, 2018, when the following were present:-
