# 1. Brief facts of the complaint

The complainant has filed a complaint stating that some persons seriously assaulted her son on 19.2.2017. On making the complaint of the incident, some one from the public at No. 100, the police turned up and took her son to the police station and detained him there but relieved the alleged persons/ assaulters. She has further alleged that on approaching the concerned ASI for registration of complaint, the ASI did not register the complaint nor did he pay any heed to prepare MLC of her son. He only forced them for a settlement, threatening to implicate her son in a false case. He also demanded Rs.20 thousand for him and for SHO. He only let them go after paying Rs. 2000/- in cash and a promise to pay the remaining Rs. 18,000/- at evening and kept her son's mobile phone (Apple) and keys of their car. She has requested for legal action in the matter.

## 2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 1<sup>st</sup> May,2017, the second hearing held on 3<sup>rd</sup> July, 2017, the third hearing held on 4<sup>th</sup> September, 2017, the fourth hearing held on 13<sup>th</sup> November, 2017, the fifth hearing held on 5<sup>th</sup> March, 2018 and the sixth hearing held on 9.4.2018, when the following were present:-

# 3 Relevant facts emerging during the hearing

No. 163/21/18 by the undersigned for judicial verdict. Now, the case is pending trial and the next date is fixed for 16.7.2018."

#### 4. Directions of PGC

As per mandate of the Commission, any matter which is sub judice in nature cannot be taken up by the Commission for hearing. The Commission has, therefore, decided to close the case due to its sub judice nature, with the advice to the complainant to pursue the case in the Court of law.
