1. Background :

Sh. Anil Dutt Sharma, the appellant vide his three applications has sought information from Deputy Commissioner (Shahdara North Zone), East DMC / the Competent Authority notified under the DRTI Act-2001.

The appellant did not receive any information in two appeals and in one appeal he was not satisfied with the reply received from the Competent Authority. Aggrieved by the same, he filed the three appeals before the Commission.

2. Proceedings

The applicant is present and heard.

Shri A.S.Meena, AE (B)-I, SHN, EDMC, is present on behalf of the Competent Authority or Department, but did not file any reply.

3. Decision

(A) Appeal No. 317/216 :- The Appellate Authority / PGC observes that relevant information has still not been furnished as directed by the Appellate Authority / PGC vide hearing order dated 12.10.2017. The Competent Authority is again directed to furnish the relevant information within 10 days of issue of this order, with a copy marked to this Commission.

(B) Appeal No. 173/2016 :- The Deputy Commissioner (Shahdara North Zone), East DMC, had been directed to provide revised replies in respect of 3, 6 & 7(a) as per hearing order dated 15.03.18, but the same has not yet been furnished. The Competent Authority is again directed to furnish the relevant information within 10 days of issue of this order, with a copy marked to this Commission.

(C) Appeal No. 165/2016 :- The Competent Authority had been directed to inform the appellant about the fees to be deposited by him for obtaining the photocopies of documents in respect of no. 3 of DRTI application. The same should be informed to the appellant within 10 days of issue of this order, with a copy marked to this commission.

The appeals stand disposed with the above direction.
