1. Brief facts of the complaint

The complainant has filed a complaint against police officials of Nihal Vihar Police Station for beating him without any reason/cause and snatching Rs. 2,000/- from him. He has requested for legal action in the matter.

2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 21st March, 2018, the second hearing held on 26th April, 2018 and the third hearing held on 8th May, 2018, when the following were present:-

3 Relevant facts emerging during the hearing

An ATR has been filed by ASI Dharambir, PG Cell/OD, stating that “ as regarding contention of the complainant during the previous hearing that he was pressurized to say particular things with respect to Rs. 2000/- snatched by PCR staff, efforts were made to contact the complainant for verification of facts but he has neither turned up for deposition nor picked up phone for verification of facts. As such further verification of allegations could not be conducted.”

4. Directions of PGC

The complainant is not present in today's hearing despite the direction given to him to appear before the Commission in today's hearing. However, the allegations/contentions of the complainant against
