1. Brief facts of the complaint

Sh. Gulab Singh filed a complaint in PGC on 17.8.2017 regarding non-payment of retirement benefits with w.e.f. 1987.

The PGC convened hearings in the complaint on 8.11.2017, 12.12.2017, 13.3.2018, 18.4.2018, 9.5.2018, 5.6.2018, 4.7.2018 and the latest on 31.7.2018

2. Facts emerged during the proceedings.

2.1 As per ATR submitted by the Respondent Deptt., "*pension set document/record received from PA-XII the pay has been fixed in respect of Late Shri Gulab Singh, Ex-Motor Lorry Driver vide order dated 27.7.2018 on the basis of promotion order dated 29.6.2018.*"

A copy of the order handed over to the representative of the deceased complainant by the AAO, I&FC.

2.1 AAO, I&FC, further informed that outstanding payments as per pay fixation order dated 27.7.2018 in respect of Late. Shri Gulab Singh, Ex Motor Lorry Driver, would be released within a day or two.

3. Directions

3.1 In view of the above and orders issued by the Deptt. regarding pay fixation /calculation vide order dated 27.7.2018, the case is closed in the PGC.

3.1 The representative of the deceased complainant is advised to remain in touch with Asstt.Accounts Officer, I&FC Department for confirmation of release of outstanding dues.

AAO, I&FC to extend all cooperation and assistance to the deceased's family in getting the outstanding dues without any further delay.
