1. Brief facts of the complaint

Sh. Naresh Trehan filed a grievance in PGC on 12.06.2015 stating that the shutter of his shop No. 210, Azad Market, Library Road, Delhi – 110006 was intentionally destroyed by the officials of North DMC. It is stated by the complainant that the said property is on the Notified Commercial Road as declared in Master Plan 2021 and is in commercial use.

2. Proceedings in the Public Grievances Commission

Under the directions from the Hon'ble High court of Delhi the case was reopened and PGC has convened five hearings and in the hearing held on 29.05.2018 the following were present :

3. Relevant facts emerging during the hearing

3.1 During the hearing held on 22.05.2018 the directions of the PGC were as follows :

Sh. R.B. Tomar, Addl. D.C. Licensing alongwith Licensing Inspector is present and apprised with the position as above in para 3.3 and is advised to examine and initiate necessary action as per DMC Act and submit the Action Taken Report on the next date of hearing.

3.2 Sh. Vinay Kumar, Licensing Inspector is present during the hearing and submit an ATR stating that :

In reference to the above matter it is stated that a temporary encroachment removal action from Azad Market, Library road, Shop No. 210 and surrounding has been taken on 29.5.2018 with the help of local police provided by P.S. Bara Hindu Rao, during the action temporary encroachment found at site was removed.

A prevention letter has already been sent to SHO/ Bara Hindu Rao with the request to direct concerned beat official to keep strict vigil at cleared site so that the encroachment may not take place again. The photographs are attached.

3.3 The complainant is also present and confirmed the action taken by the Licensing Department, North DMC and he was satisfied with the action taken by them.

4. Directions of the PGC

Hon'ble Delhi High Court has also vide its orders dated 28.5.2018 ordered for removal of barbar shop. The action has already been taken by the MCD authorities. In the light of the ATR and High Court Order no such encroachment, once removed by the MCD should be allowed to re-occur.

With the above directions the case stands closed at the level of PGC.
