## **1. Brief facts of the complaint**

The complainant has filed a complaint stating that on 9<sup>th</sup> April, 2017, he was coming back at 4.00 am in the morning with his two friends on scooty, after having some paratha from nearby Safdarjung Hospital. Two cops stopped him near D Park Safdarjung Enclave and they tried to search their pocket badly like punk. Police asked to show scooty papers. He showed all the documents except one paper. He alleged that while checking documents, they used abusive language with them. On protest, they used more abusive words and started to hit him with police baton. They hit 7-8 stick on his thigh. While hitting, they broke his new I Phone 7 plus 128 GB, which costs 82000 INR and after they police forcefully grabbed the scooty key and said "chori Ke Kesh me jail me daal dunga" and seized his scooty No. DL9SAJ-3461. He filed the FIR against Broken phone matter which was received by SI Balraj and after two days on 11.4.2017, he also filed complaint with Spl. CP/Southern Range, ITO. He alleged that four months have passed but he has not got any positive response from DCP/Hauz Khas Office. The complainant has requested for legal action in the matter.

## **2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 14.11.2017 and the second hearing held on 19<sup>th</sup> January, 2018 when the following were present:-
