1 Brief facts of the complaint

The complainant has filed a complaint of extortion of Rs. 2 lakhs by two policemen with the threat to implicate in false case. He has alleged that on 14.5.2018, two policemen approached him, while he was sitting alongwith his two friends in a park, and asked them to sit in the vehicle and shown them a list of 15 people and asked to get them recovered. He has further alleged that the said policemen asked them for Rs. 5 lakhs with the threat to implicate them in false case and finally extorted Rs. 2 lakhs from him. He has requested for registering a case and further legal action. When he was called in the Commission he stated that though he made complaints to various police authorities but no action in the matter was taken on his complaints.

2. Proceedings in the Public Grievances Commission

The PGC has convened three hearings in the case since 6.8.2018 and at the hearing held on 10.9.2018, the following were present :-

3. Relevant facts emerging during the hearing

3.1 ATR filed by Insp. Subhash Kumar (Invst.) from PS Sonia Vihar is on record.

3.2 Inspector Subhash Kumar, Investigation, PS Sonia Vihar submitted that on the basis of the CDR analysis, the alleged Rajesh @ Rizwan Khan has been identified. It is further submitted that on the basis of preliminary enquiries, it has been established that the complainant Rinku Jaiswal has been cheated and defrauded by the alleged Firoz and Rizwan. He further assured that a criminal case against the alleged persons will be registered in a day or two and thereafter, the investigation will be taken up with sincerity.

4. Directions of PGC

A report to this effect be submitted within 10 days, failing which the case will be listed for hearing in the matter.
