1. Brief facts of the complaint

The complainant has filed a complaint of inaction against Delhi Police on her complaint of physical assault and molestation by her in-laws. She has alleged that on 8.4.2018, while she was alone at home, her brother-in-law (jeth) asked for food. When she came out of the room after serving the food to her jeth she was held by him by the breasts and he squeezed her breasts. Any how with efforts she made herself free from his clutches and when she narrated the incident to her mother-in-law and her husband, they only rebuked her. She has further stated that though a complaint was made at NO. 100 , but police did not take any action on her complaint. She has requested for legal action in the matter.

2 Facts emerging during the proceeding

An ATR has been filed by ASI Ram Bhool, CAW Cell/North East stating that “ the complainant filed a request with the CAW Cell/North- East for re-opening her case. Accordingly, a case has been re-opened and the opposite party has been issued a notice through SHO/Jyoti Nagar calling at CAW Cell for counseling. The next date of hearing is 17.7.2018. Necessary action will be taken accordingly.”

The complainant is present alongwith her mother and reiterated her allegations as leveled in her complaint. She also stated that she was a victim of domestic violence since her marriage and she made a complaint in this regard on 26.11.2012 at PS Mansarovar Park also.

3. Directions of PGC

The case be registered and transfer the investigation of the case to CAW Cell under the supervision of Inspector CAW Cell.

A compliance report shall be filed in the Commission within one month of receipt of this order. With this advice, the Commission has decided to close the case in PGC.
