1. Brief facts of the complaint

The complainant has filed a complaint of inaction against police officials of PS Burari on his complaint of beating him by Subhash and his associates. He stated that on 28.7.2017, he made a PCR call that he was beaten by Subhash and his associates with the intention to kill him. No police officer recorded his statement. When he himself approached SHO he was told that they would not take any action against Subhash and his associates. He has alleged that the said Subhash and associates have good relations with local police so that do not have any fear of law. He has requested for legal action in the matter.


