### 1. Brief facts of the complaint

2.1 On the last date of hearing held on 16.5.2018, the Commission directed MD, DSIIDC to do the needful without any further delay in the meeting scheduled for 24.5.2018 with proper representation by all the members and send the recommendations to Hon'ble L.G., Delhi.

2.2 An ATR has been filed on behalf of Sh.Vinod Kumar, DCI (Policy/Relocation) Industries deptt. Stating therein that:-

"A meeting of the Land and Flat Allotment Committee was rescheduled on 25.5.2018 to deliberate the cases relating to allotmnet of plots to the applicants under the Relocation Scheme. In the meeting, the case of M/s. Janki Metal Industries was also deliberated and the Committee recommended to allot a plot to the applicant. Now, the matter will be submitted to the Competent Authority i.e. Hon'ble L.G. for his consideration and approval.

# 3. **Direction of the PGC**
