1. Brief facts of the complaint

The complainant has filed a complaint in PGC alleging that her husband Mohan Singh Negi has been beating her for the last one year. She made several complaints at PS Model Town and at No. 100, but no action was taken on her complaint. She further alleged that he also tried to kill her by giving poison to her when she was pregnant. He also tried to kill her with knife. She also alleged that police freed her husband after making a parcha of 751 by taking money from him and made a weak case. She further alleged that on 7.2.2017, he came alongwith 15-20 girls and thrown her out from the house. She made a call at No. 100, but instead of taking action, SHO scolded her. The complainant has also alleged that police is trying to implicate her father, sister and brother in law in false cases. The complainant has requested for necessary action in the matter.

2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 4th January, 2018, the second hearing held on 9th March, 2018, the third hearing held on 26th April, 2018, the fourth hearing held on 17th May, 2018 and the fifth hearing held on 14th June, 2018, when the following were present:-

3 Relevant facts emerging during the hearing

An ATR has been filed by sent by ACP/PG/NWD dated 1.6.2018 by Ramesh Kumar, ACP/PG/NWD and received in PGC on 6.6.2018 stating that “ as directed by this Hon’ble Commission, complainants were called in DCP office/North West District on 25.5.2018. Worthy DCP/NWD met with the complainants and heard their grievances. Thereafter, DCP/NWD directed SHO/Model Town and SHO/Adarsh Nagar to take preventive measures and ensure the safety of the complaintant and her family members from the accused Mohan Singh Negi. The compliance of directions issued by the Hon’ble Commission has been complied with accordingly.”

4. Directions of PGC

The complainant is not present. However, her sister is present on her behalf and stated that they met the DCP/NWD, who has instructed the SHOs to take appropriate action against the alleged. She also stated that a PSO has also been provided to her sister

DCP/NWD has given a hearing to the complainants and has directed the concerned SHOs to take preventive measures to ensure the safety of the complainants.

The complainant is further advised if any threat is extended to her in future, she will make a call at No. 100, lodge a complaint in local police station and also meet DCP/NWD. On receiving the complaint, the concerned SHO shall take legal action on her complaint as per law.

With the above advice, the Commission has decided to close the case in PGC.
