## **1. Brief facts of the complaint**

The complainant has filed a complaint stating that on 23.8.2017, there was a theft occurred at his residence. The only person left behind was his daughter-in-law at home. He alleged that his daughter in law had already threatened him that she would steal all their important documents from home. When they come back home in the evening they found that cash and documents were missing. They called at No. 100. The police asked him to come to PS to lodge FIR. They visited the police station. The policemen told him to change the contents from theft to misplace. The complainant has alleged that there is connivance between her daughter-in-law and local police. He further alleged that policemen even did not bother to visit the home to check the finger print on the lock and utensil in which papers were kept. The complainant has also alleged that whenever her daughter-in-law lodged complaint against them, police came several times to home and threatened them to put behind the bars in various false cases and police helping his daughter in law to grab the property. The complainant also alleged that her daughter-in-law tried to murder/kill her mother in law also 3-4 times. That fact was also mentioned in their application, but no action was taken on the said application. The complainant also alleged that once her 4 brothers came to his home for talk on 18.10.2015, but instead of talking with us, they started threaten to kill them if he did not name the property in the name of his daughter-in-law, and also tried to kill/murder his son by strangling his throat and cut him into pieces. The complainant has requested for legal action in the matter.


## **3 Relevant facts emerging during the hearing**

The instant matter relates to marital discord. As a result, the case has been registered by the lady against her father-in-law which has agitated over the registration of the case as informed by the ACP/PG Cell and IO. The complainant is a poor person and does not have economic resources to sustain himself.

### **3. Directions of PGC**

IO is directed to speak to both the parties and arrange counselling by professional counsellors of Delhi police to reconcile the discord.
