### 1. Brief facts of the complaint

The complainant has stated that her daughter Shunali Gupta has filed an FIR No. 75/2015 at PS G.K. Part-I, New Delhi against Shri Yash Bindlish & his family who have thrown her out from the house after even six months of marriage and kept all her belongings with them. He alleged that police authorities have still not filed an official case against the culprits, even when all the proceedings at Women Cell, original documents & verification of marriage expenses have been verified by them. He stated that police again and again calls them at PS and harasses them, whereas the alleged party has never been seen there, knowing that they are resourceful people, staying at E-196, Greater Kailash-2, New Delhi. He also alleged that every time police promises that the case will be initiated against the alleged, but nothing has moved till date. He also alleged that Yash Bindlish is a regular drunker and he is threatening his daughter. He also alleged that the alleged made her daughter's phone snatched on the road, for which an another FIR has been lodged at GK-1 Police Station. He has also expressed his apprehension that Yash Bindlish will flew away from the country leaving all of them in dark. The complainant has requested for immediate action for arrest of Yash Bindlilsh.

### 2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 22.8.2017, the second hearing held on 19<sup>th</sup> September, 2017, the third hearing held on 21<sup>st</sup> November, 2017 and the fourth hearing held on 6<sup>th</sup> February, 2018, when the following were present:-
