## **1. Brief facts of the complaint**

The complainant has filed a complaint alleging that he was booked by SI Naresh Kumar of PS Geeta Colony illegally and released by the court with fine of Rs. 100/- on 13.8.2017. He further alleged that on 16.9.2017, he was stopped by Ct. Dharamveer and his motor cycle was seized u/s 66 DP Act without reason. He also alleged to arrest him in a false case by Beat Officer SI Naresh and Dharmender Hude. They also forcefully took away the money from his pocket. He also alleged demand of monthly bribe by the said police officials. The complainant has requested for legal action in the matter.
