### **1 Background :**

The appellant vide his DRTI applications dated 7.12.2017 has sought information on total 08 points each. Aggrieved by non-receipt of information from the Competent Authority, he filed these appeals.

### **2 Proceedings**

The appellant is present. Sh. Parmanand, Asstt. Assessor and Collector K.B. Zone, North DMC is present on behalf of the respondent. The representative of the department has furnished a copy of the reply dt. 21.8.2018 vide which point-wise reply has been sent to the appellant. The reply has been perused.

The appellant sought information relating to 04 properties viz. (a) T-841, Faiz road Chowk, DB Gupta Road Karol Bagh, (b) T-581, Faiz Road, (c) T-460, Faiz road Chowk, DB Gupta Road Karol Bagh, and (d) T-874, Faiz Road. The department has provided satisfactory information in respect of Property no. mentioned at (a) and (c) above. During the course of discussion in the case, the departmental representative informed that property no. T-874 has now started paying tax on line. A copy of record available with the department was provided to the appellant during the hearing. As regards Property no. T-581, the departmental representative informed that no record regarding payment of tax is traceable in the department. He assured the Commission that notice shall be issued to the owner for depositing the property tax.

### **3 Decision**

Since the department has provided satisfactory information to the queries of the appellant, the appeal cases are ordered to be closed in the Commission. However, a copy of notice issued to the owner of property no. T-581 Faiz Road, Karol Bagh, New Delhi for depositing the tax may be sent to the Commission for perusal.
