### Brief facts of the complaint

The complainant has informed that he has filed a complaint at PS Paharganj on 21.10.2014 with documentary evidences and the investigation was assigned to ASI Heera Lal on 25.11.2014. ASI Heera Lal and SHO (Pharaganj) have allegedly submitted fake reports in collusion with accused persons. The complainant has also enclosed copy of several documents which were submitted by him before the DCP and other authorities concerned. Vide his letter dated 10.3.2015, in reply to the RTI application filed by the complainant, ASI Heera Lal informed that he is waiting for a reply of postal department and on receiving the reply he will initiate further action but even after lapse of 14 months no action has been initiated by the said IO. The investigation was subsequently transferred to another IO/SI Kishore Kumar who also did not take any action on the complaints of the complainant. The complainant has alleged that the enquiry officers are knowingly and willfully delaying the action on the complaint of the complainant in collusion with the alleged party.

The complainant has requested the Commission to look into the matter and direct the police authorities to register a FIR and initiate necessary legal action against the accused persons in accordance to the provisions of law.

#### 2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 3rd February, 2016, the second hearing on 16<sup>th</sup> March, 2016, the third hearing on 25<sup>th</sup> May, 2016, the fourth hearing on 13<sup>th</sup> July, 2016, the fifth hearing on 17<sup>th</sup> August, 2016, the sixth hearing on 5<sup>th</sup> October, 2016, the seventh hearing on 14<sup>th</sup> December, 2016, the eighth hearing held on 22<sup>nd</sup> March, 2017, the ninth hearing held on 31<sup>st</sup> May, 2017, the tenth hearing held on 2<sup>nd</sup> August, 2017, the eleventh hearing held on 20<sup>th</sup> September, 2017, the twelfth hearingheld on 22<sup>nd</sup> November, 2017 and the thirteenth hearing held on 7<sup>th</sup> February, 2018, when the following were present:-

### Relevant facts emerging during the hearing

An ATR has been filed by SI Nitin Nawani, PS Paharganj, stating the following:-

- iii. It is submitted that this Hon'ble Commission vide its Order dated 20<sup>th</sup> September, 2017 directed SHO/Paharganj to register an FIR on the complaint of Ms. Kailash Newar, the same received in this PS vide Endst. No. 1533, dated 21.10.2014 SHO/Paharganj. As per the direction of this Commission, a case vide FIR NO. 308/17 u/s 420/468/471 IPC was registered at PS Paharganj.
- iv. It is further submitted that initially the investigation of this case was handed over to DIU /Central District but latter the investigation of the case is handed over to undersigned. The investigation of the case is in initial stage and during investigation a request to supply the alleged forged documents was put up before Hon'ble DRT Court and the Hon'ble DRT court fixed 8.2.2018 for hearing. It is further submitted that the notice u/s 92 & 91 Cr.P.C. was also issued to Supdt. of Post and Commissioner of Factories respectively and the reply in this regard is still awaited."

#### Directions of PGC

It is observed that with the intervention of the Commission, the police has registered FIR in the matter, thus, the grievance of the complainant is redressed. However, IO is advised to keep the complainant informed about the progress in the matter.

With the above advice, the Commission has decided to close the case in
