## **1. Brief facts of the complaint**

The complainant has filed a complaint of inaction, pressuring him for a compromise and threatening him against the SHO/PS Sultanpuri. He has stated that he alongwith his family members were beaten and abused by Kamlesh, Radha and their family members. They were beaten even in the presence of ASI Dharam Singh who visited the site of quarrel to verify the allegations. ASI supported the allegations leveled by them and recommended action against the alleged persons. Even the SHO was intending for a action against the alleged but with the intervention of Rama Nand Bindal, the course of action was reversed and SHO let the alleged go free and pressurized the complainant for a compromise. The complainant approached the DCP with his grievance but no action was taken. He has requested for legal action in the matter.

The PGC convened its first hearing in the complaint on 1<sup>st</sup> February, 2018 and the second hearing held on 8<sup>th</sup> February, 2018, when the following were present:-


