Since the parties involved in the Appeals are common, various Appeals are being clubbed together for hearing and disposal to avoid multiplicity of the proceedings and effective adjudication.

1 Background :

The appellant vide DRTI application dated 29.12.2017 has sought information on total 22 points each. Aggrieved by non-receipt of information from the Competent Authority, he filed these appeals.

2 Proceedings

The appellant is not present. Sh. C.P. Sharma, A.E. (Bldg.), K.P. Zone, North DMC is present on behalf of the respondent. The representative of the department informed that point wise information has already been furnished to the appellant vide letter dt. 21.03.2018. He submitted a copy of the same in the hearing today.

The reply of the department has been perused. The Commission tends to agree with the department that the information sought is voluminous, since the appellant has sought information on 22 points each relating to all the wards under the jurisdiction of K.P. Zone, North DMC in 07 appeals.

However, the department shall furnish a revise reply in respect of query no. 02, vide which the appellant has sought information regarding number of complaints received in the control room against unauthorised construction for the period 1.7.2017 to 28.12.2017. The department had replied that DRTI application has been transferred to APRO, Keshavpuram Zone for necessary action.

3 Decision

The Competent Authority viz. Dy. Commissioner, K.P. Zone, North DMC is directed to collect the relevant information in respect of point no., 02 and furnish the same within 15 days of issue of this order directly to the appellant with a copy endorsed to this Commission for information.

Further, with regards to point no. 12 the appellant is advised to visit the office of the Executive Engineer (Bldg.) Keshavpuram Zone on any working day, with prior appointment, to inspect the relevant record and obtain photocopies of the documents after payment of requisite fees as prescribed under the DRTI Rules 2001.

With the above advice, the matter is accordingly disposed of at the Commission's end.
