#### 1. Brief facts of the complaint

The complainant has filed a complaint in PGC alleging that he made complaints to DCP/North East, CP/Delhi, Home Minister/Secretary, MHA, New Delhi through Speed Post against IO/SHO, PS New Usmanpur Police. Now, police of PS New Usmanpur is making pressure on him to withdraw the said complaints. IO/SHO of case FIR NO. 232/2017, u/s 376-D, PS New Usmanpur has falsely implicated hilm and his son in the case, due to which his son namely Shafiq Alam had to jailed for 15 days. He also stated that in case FIR No. 1140/15, u/s 302 IPC, PS New Usmanpur, he and other 25 persons were called in PS for enquiry and all were released after taking 5-10 thousand rupees. He was also asked to give 10 thousand but when he showed his compulsion to not give the said amount, Police left him. Almost 20 months of that incident now, why has Inspr. Narender Kumar issued notice to hilm on 6.6.2017. The complainant has requested to take necessary action into the matter.

#### 2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 11th September, 2017, the second hearing held on 27th November, 2017 and the third hearing held on 5<sup>th</sup> February, 2018, when the following were present:-
