## **1. Brief facts of the complaint**

The complainant has alleged that on 26.12.2016 he met with an accident near C-3 Block, Nand Nagri, Delhi. He was brought to GTB hospital by his brother. MLC vide No. A-1021/53/16 was prepared by doctors. He visited the police station where ASI Ram Kunwar met him but ASI did not record his statement. The complainant further alleged that on 6.3.2017 he met Inspector Vijay Kumar Dhayia and Constable Anuj. Inspector Vijay Kumar Dhayia said to him that "HUM TUMHARI ACCIDENT KI REPORT NAHI LIKHTE KYUNKI TUM CHAMAR HO AUR HUM CHAMAR KI TO BILKUL NAHIN LIKHENGE". The complainant has requested for taking necessary action in the matter.

## **2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 19<sup>th</sup> June, 2017, the second hearing held on 28<sup>th</sup> August, 2017, the third hearing held on 6<sup>th</sup> November, 2017, the fourth hearing held on 8<sup>th</sup> January, 2018 and the fifth hearing held on 19<sup>th</sup> February, 2018, when the following are present :-
