## **1. Brief facts of the complaint**

The complainant has filed a complaint stating that on 30/7/2017 at about 9.30 p.m., two policemen wearing uniform without name plates took his younger brother Puran Gupta and when he (Puran Gupta) opposed, they stopped the vehicle nearby water reserve tank and beaten his younger brother very badly. He further informed that somebody made a call to him regarding the incident and he alongwith Sumit Prasad Gupta reached at the place of incident. Police also beaten Sumit Prasad when he told the police that police should not have beaten Puran. He alleged that his younger brother got injuries on his head at 6/7 places and Sumit Prasad got injuries at his nose, lips and shoulders. He also informed at No. 100 but police did not come at the spot. He took his brother to Jag Pravesh Chander Hospital for MLC but police did not allow for conducting the MLC. He made a call at No. 100. Police came and then MLC was conducted. He further alleged that instead of taking Sumit Prasad to hospital for medical treatment, police took him to PS New Usmanpur, where he was beaten and kept him in custody illegally. When he requested the ATO Narinder Kumar to provide medical treatment to Sumit Prasad, the ATO Narinder Kumar abused and beaten him as well, and snatched both his mobile phones and Rs. 20,000/- and also detained him illegally in the police station. He also alleged that police asked him to arrange for Rs. 10,000/- from his house and only then released him after taking memory card of his mobile phone as he had recorded a video clip of beating from his mobile. After coming from PS, he again made another PCR call as the condition of Sumit Prasad was very bad. Further, at about 4.35 am, MLC of Sumit Prasad was prepared. He also

alleged that one police person who had beaten him was Vedpal. The complainant has requested for necessary action in the matter.

## **3 Relevant facts emerging during the hearing**

On the hearing held on 16<sup>th</sup> October, 2017, the complainant was present and was given a copy of the ATR filed by Delhi Police for information and furnishing his comments, if any, on the next date of hearing fixed for 8.1.2018. Neither he was present on the last date of hearing nor he sent his comments in PGC. He is not present in today's hearing also. It appears that he is not interested in pursuing his case in PGC.

In view of the above, the Commission has decided to close the case in PGC.
