**1. Brief facts of the complaint**

The complainant has filed a complaint in PGC stating that her husband worked as a vehicle driver in a factory. He left home after receiving a call from the factory. She came to know after some hours that he is injured and admitted in SGM Hospital, Mangolpuri, Delhi. After treatment, he was referred to Sardarjung Hospital. She also stated that during the treatment, when her husband came in conscious condition, he nodded ("Ishhara") regarding quarrel and of being beaten. He expired in the hospital. She further stated that she is not aware as to how her husband received injuries on head and body and the reason of death. The owner of the factory said that her husband expired due to fall of iron sheets which she does not believe. She suspect that her husband was murdered and it was not an accident. She alleged that she is not satisfied with the police action. The complainant has requested necessary action in the matter.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 13<sup>th</sup> July, 2017, the second hearing held on 3<sup>rd</sup> August, 2017, the third hearing held on 12<sup>th</sup> October, 2017 and the fourth hearing held on 15<sup>th</sup> February, 2018, when the following were present:-


