1 Background :

The appellant vide DRTI application dated 8.8.2017 has sought information on total 04 points respectively. Aggrieved by non-receipt of information from the Competent Authority, he filed this appeal.

2 Proceedings

The appellant is present. Sh. Kishan Swaroop, Admn. Officer, Shahdra North Zone, EDMC is present on behalf of the department. The representative of the department has furnished a reply dated. 2.1.2019 vide which point-wise information has been provided to the appellant.

The reply has been perused. The appellant states that he is not satisfied with the information provided in respect of query no. 01. He states that it is in his knowledge that licenses for farmhouses, motels etc. are issued by the General Licensing Branch. However the departmental representative strongly refutes the same and states that such licenses are issued by the Health Department. He has further agreed to provide copy of guidelines relating to the functioning of the General Licensing Branch.

It appears that the department has provided satisfactory information to the queries of the appellant. However, if there is any documentary proof available with the appellant that such licenses have been issued by the General Branch, then a copy of the same may be provided to the Dy. Commissioner, Shahdra North Zone, EDMC under intimation to this Commission.

Further, the Competent Authority viz. Dy. Commissioner Shahdra North Zone is directed to provide a copy of the guidelines relating to functioning of the General Branch, to the appellant as discussed in the hearing today.

3 Decision

Since satisfactory information has been provided to the appellant by the Competent Authority viz. Dy. Commissioner, Shahdara North Zone, EDMC, no further action is required to be taken by the department, except in respect of query no. 1 as discussed above.

The matter is accordingly disposed of at the Commission's end.
