1. Brief facts of the case

1.1 Shri Kushal Kumar, complainant, filed a complaint in PGC against BSES for

issuing disconnection notice of Electricity Connection No.152230286.

2. <u>Facts emerged during the proceedings.</u>

2.1 No ATR has been filed. However, the complainant stated that all the

documents have been submitted to BSES RPL. As regards desealing of the property,

it was informed by the complainant that the same has not been done and it will take

some time by the concerned authorities to deseal it. He assured that as soon the

desealing process is complete, necessary documents with regard to desealing and

other relevant documents will be submitted to BSES RPL for their information and

record. He requested to close the case in the Commission.

2.2 The representative of BSES RPL stated that there has been no disconnection of

the above Electricity Connection and no action for disconnection of electricity

connection will be taken in future subject to condition that complainant pays his

bills regularly and he should also submit the necessary papers regarding desealing of

property as soon as possible.

2. <u>Directions</u>

- 2.1 In view of the above, the case of the complainant is disposed in the Commission with the advise that the complainant should ensure payment of regular bills to BSES RPL and provide all other relevant documents including the desealing documents for information and record of BSES RPL.
- 2.2 The BSES RPL may take necessary action as per rules in the event of complainant failing to comply with the above directions.
