1. Brief facts of the case

1.1 The present matter has been taken up suo moto by the Commission

based on media reports published in the "Hindu, Indian Express and Navbharat

Times" dated 06.3.2018 and 07.3.2018 respectively highlighting dereliction of

duty on the part of the officials of Department of Women & Child Development,

GNCT of Delhi regarding payment of minimum wages to the contractual

workers.

2. Facts emerged during the proceedings

2.1 An ATR has been filed by Programme Manager(SCPS), Department of

Women & Child Development, GNCTD stating that minimum wages has been

approved by the Finance Department, GNCTD and file is under submission to

Member Secretary i.e. Director (WCD), GNCTD for final disbursement of

minimum wages to the staff working under ICPS Scheme w.e.f. January, 2017.

2.2 The Programme Manager(SCPS) further informed that the wages will be disbursed within one week positively.

3. <u>Directions</u>

- 3.1 The Commission takes this opportunity to observe that it took almost 8 -9 months to get legitimate dues of minimum wages which was as per Govt. regulations & programmes and the workers case was taken suo moto by the Commission and pursued vehemently. The delay shows the sad state of affairs but still Commission appreciates the efforts taken by the Deptt.of Women & Child Development, GNCTD in pursuing this case.
- 3.2 In view of above, the case is disposed in the Commission with the advise that the Director(WCD), GNCTD shall ensure disbursal of the enhanced wages to the workers without any further delay under intimation to the Commission.
