### **1. Background :**

Shri Ram Sewak Sharma, appellant, vide his DRTI application dated 16.05.2018 has sought information on total 1 point.

The appellant did receive the information from the department, but he was not satisfied with the same. Hence, he filed this appeal before the Appellate Authority / PGC.

### **2. Proceedings**

The appellant is present and heard.

Shri Gulshan Ahuja, ARCS, is present on behalf of the Department.

The officer submitted a revised reply vide which a copy of the statement, as sought by the appellant through his DRTI application, has been obtained from the bank. A copy of the same was handed over to the appellant during the course of hearing today.

The appellant states that he had taken a loan from the Delhi State Co-operative Bank Ltd., Nand Nagri and according to him, he has not only re-paid the full amount but has deposited the excess amount with the bank. He further states that the bank officials had assured him that the excess amount, if any, shall be refunded to him but till date he has not been refunded the same.

### **3. Decision**

**Since appropriate information has been made available to the appellant by the department under the Delhi Right to Information Act, 2001, no further action is required to be taken as far as the appeal under Delhi Right to Information Act, 2001 is concerned.**

However, as regards the submission of Shri Ram Sewak Sharma, that he has allegedly deposited excess amount against the loan taken by him is a matter of grievance is not under consideration at the present stage. But Shri Gulshan Ahuja, ARCS, was advised to look into the matter and try and settle the issue between the bank and the appellant through his good offices.

**With the above direction, the matter is ordered to be disposed of in the Commission.**
